 - Tina and the board have reviewed and approved the budget.

 - **Bill Cameron/HOA Property Parcel**
 - Prior to opening of meeting, Bill Cameron proposed to board that he would like to gift the rest of the unused land adjacent to Lantana, majority of which is wetlands. Bill has some work to be done prior to giving the land including clearing ditch and tree clean up. Board wants homeowner input and idea was proposed to send out a homeowner survey. Also, board wants to do further research of land prior to making decision to accept or decline gift.
